MEMBERSHIP, DUES PAYMENT AND DUES DEDUCTION AUTHORIZATION

Yes, I want to join with my fellow employees and be a committed member of the Local Association, the Arkansas Education Association (AEA), and the National Education Association (NEA). I hereby request and voluntarily accept membership in these associations and agree to abide by the Constitution and Bylaws of all three associations, as they may be amended from time to time. I support the Local Association in its role as my exclusive representative in collective bargaining over wages, hours, and other terms and conditions of employment.

I hereby (1) agree to pay annual dues uniformly required for membership in the Local, AEA and NEA; and (2) request and authorize my Employer to deduct from my pay in each pay period, and transmit to AEA or its designated agent, a pro rata portion of the annual dues required for membership in the Local, AEA and NEA, unless I pay dues by check or EFT. I fully understand that the dues required for membership in the three associations are subject to periodic change by the associations' governing bodies and authorize dues payment on a continuing basis, and regardless of my membership status, unless my obligation to do so ends under one of the circumstances below.
